feeling of choking; (6) chest pain or discomfort; (7) nausea or abdominal distress;

(8) feeling dizzy, unsteady, lightheaded, or faint; (9) derealization (feelings

of unreality) or depersonalization (being detached from oneself); (10) fear

of losing control; (11) fear of dying; (12) paresthesias (numbness or tingling
